# Draft Minutes of the meeting of The APFNDT General Assembly Meeting held At Sunway Putra Hotel in Malaysia

# 23rd November: Commenced at 1410 hours

## 1. Welcome

The President thanked all for their attendance and also extended gratitude to the Malaysian Society for Non-Destructive Testing (MSNT) for its excellent organization and hosting of the meeting.

## 6. AFNDT Documentation

#### **6.1** Constitution

The General Secretary opened discussions on possible small amendments previously requested by the ChSNDT delegate on naming conformity around "Country/Society" and the status of Working Groups being changed to Task groups, therefore being applied. However, with the requirement to then re-format and present a new Constitution for Japanese Law that this may be a costly exercise and may be better to be reviewed later.

At this time, Mr. Clausing raised a point of order, in that although the Constitution had been tabled by the President with existing amendments, there was perhaps more "pending discussions" in the agenda on the discussion around ICNDT, that any formal amendments be held over until the Next GA in 2017.

# 6.2 Operating Procedures Cont.

Operating Procedure10 was tabled for discussion by the GA, with the discussion being based around the term "Official Delegates" of APFNDT getting Free Registration at APCNDT Conferences. Wherein this could possibly be taken to extremes and host societies could end up with suffering undue expectations for zero registration cost.

As the reason this requirement was added to the guidelines originally, was to ensure that "Voting Delegates" would come to the General Assembly meetings held during every APCNDT Conference.

Therefore the meeting agreed to amend the wording to "Voting Delegates of APFNDT"

Operating Procedure 11 needs to be expanded to include other countries, such as Iran and Vietnam. The membership TG is to review the master list against APEC lists.

### 7. Strategic Plan

The General Secretary advised the meeting that the Strategic Plan was still under consideration by the Executive, but is to be placed before the next GA in Singapore 2017.



## 8. Financial Reports

## 8.1 Income/Expenditure

The Treasurer (Mr. Babu) presented the financial status, approved by the board, via a power point presentation

## 8.2 Budget for coming year

The Treasurer (Mr. Babu) relayed that with minimal monies held in reserve, that no expenses have been budgeted for until additional membership fees are received.

## 9. Reports by APFNDT internal committees and task groups

### 9.1 Advisory Group Report

The Board had at the prior meeting initiated the Inaugural Members of the AG as requested by the President:

Discussion around the 2003 President: Prof Kwon, also being available were tabled with the KSNT reps present for clarification and his acceptance?

# 9.2 Task Group Reports

# • TG1 Membership

With no formal report being available due to the lack of nominees from societies, Board delegates had been tasked with completing the filling of positions on TG1.

### • TG2 APFNDT Journal

With the TG almost complete (except ISNT & ASNT) the first meeting was planned for Munich 2016.

# • TG3 Communications and website

With little material coming in, there has been no newsletters in 8 months Mr. Ooka needs input and support for this to happen.

# • TG4 Education and Training

ISNT are seeking nominations for this TG (with a large group of societies suggested as possible supporters), ISNT is also planning for a possible APFNDT Workshop on TOFD and PAUT.



# • TG5 Certification

Chair of TG5 had sent an apology for no report, but also that there would be a meeting in Munich 2016.

## • TG6 Standards

With no other members other than Dr. Ogata at this point the TG was inactive.

### **10. Asia Pacific Conferences**

## 10.1 Report on APCNDT 2017 (Singapore)

The hosts NDTSS presented a power point on the planning thus far, saying that they needed 750 delegates (with 500 needing to come from overseas).

Mr. Wadyalkar suggested as a cost savings, that the WCNDT 2020 & the APCNDT 2021 could share the required "free trade stand", so that NDTSS could sell one more of the limited exhibition spaces.

Mr. Pari again asked for BULK discounts % off and Day Delegate Fees. However with very tight financials around the event, discounts were looking out of any possibility.

## 10.2 Report on APCNDT 2021 (Australia)

Mr. Wadyalkar reported that moving on with more actual organizing would not begin until 2016, with a plan to be presenting as ready at the 2017 event.

# 11. Reports by External Organizations

Mr. Clausing took the opportunity to request support for the ASNT bid for a WCNDT Conference in 2024 and ISNT requested support for the same in 2028.

# 12. Opportunity for comments by National Societies

Dr. Wai Zin Oo of Myanmar was invited earlier to speak on their plans to form an NDT Society. Although this is not the first introduction of such by Myanmar delegates, the GA wished them luck and support wherever possible. Hoping that with a pending Regime change in country that more positive moves may soon be possible.

# **13. ICNDT Structure and Fees**

The President opened the discussions on the possible restructure of ICNDT, tabling the boards opinion on our best way forward with all this. But also requesting that we seek Members Support for the changes proposed.

With the "Statutory Requirements" of Eight (8) weeks, notice we would be looking for a decision by late January  $19^{th} - 22^{nd}$  (latest), so that our decision could be relayed to the next ICNDT IEC Meeting on January  $29^{th}$ .



Secretariat to forward a form set for all Member Societies to complete and return prior to an Executive webinar on January 22<sup>nd</sup>.

#### 14. Closure of Meeting

"In closing, the President thanked all those attending and specifically wished to relay the point that the Asia Pacific Regional Group would be completing 40 years of formal existence in 2016 and that we should be looking for a "Grand Celebration at the 2017 Event" with large numbers encouraged to attend for that reason".
